General Information and Show Rules

DATES: Saturday and Sunday, February 25 & 26, 2012

TIME: 10: 00 AM to 5:00 PM Saturday and Sunday

SET-UP: Saturday 6:00 AM for Whitehead St. – **7:00 AM for Caroline St.**

TEAR DOWN: Must be completed by 7 pm on Sun.

Parking: Free in nearby lot.

ELIGIBILITY: NO dealers, stores or agents may participate. The artist must be present for the entire show and present ID at check in. Exhibitors must be checked in by 8:00 AM on Saturday. If not, the artist may be considered a no-show and his/her space can be reassigned. Work is fine art, and must meet show criteria. (see prospectus)

PRINTS: Original artwork is the focus of the show. Framed reproductions may be hung on only one wall of the booth not to exceed 10 linear feet and must be labeled as such. (see prospectus for details)

SPACES: Spaces are assigned by the committee, which tries to honor requests, **but makes no guarantees.** Each 10' x 10' is \$200, limited 10' x 15' spaces are available for \$300.

JURY FEE: \$25 in a separate check made payable to Old Island Days Art Festival.

SECURITY/INSURANCE: Police are on duty 24 hour during the show and set-up/tear down. The OID Art Festival is not responsible for insuring exhibitors' work or displays and cannot accept responsibility for theft or damage.

REFUNDS: The OID Art Festival Committee is not required to make refunds within 60 days of the event.

PLEASE NOTE: The OID Art Festival has a ZERO tolerance policy for buy/sell, mass produced items, post cards, stationary, books, artist reps or **items unlike those juried.** Work must be produced by the exhibitor. This will be strictly enforced with no exceptions.

APPLICATION PROCESS: Along with application and checks, send a CD with 3 jpg images of your work & 1 of display. Name files with artist name, media & image number. Number 4 should be booth (example: Joe Smith Watercolor1.jpg) Suggested format 1920 x 1920.

Booth fee checks will not be deposited until 2 weeks after acceptance. Include a self stamped return envelope. CDs of accepted artists will be held until show and others returned, if appropriate envelope and postage is included.

DEADLINES: Entry to be **postmarked by October 1, 2011.** Notifications will be mailed no later than November 1, 2011. Late applications may be subject to a late fee.
